Tourist Visa "TR" (not exceeding 60 days)

You must be physically located within Canada when applying for the visa

Non-Thai nationals who wishing to enter Thailand for Tourism purposes

Step 1 – Online e-Visa Application

The applicant who does not have a valid visa or re-entry permit must apply for a visa by:

- A. Complete the online e-Visa Application at https://thaievisa.go.th/ and
- B. Upload the following documents in PDF format:
 - 1. One passport-size photograph (2"x2" JPEG format) taken within 6 months. Photograph must have a light color background with a full- face view of the person without wearing a hat or dark glasses and covering up shoulders
 - 2. A copy of Passport (must not expire within 6 months) (JPEG format)
 - 3. A copy of **a round trip** flight ticket/ itinerary, showing going from **Canada to Thailand** and departing **Thailand** (The name of the applicant must indicated clearly).
 - 3.1 A copy of **a round trip** flight ticket/itinerary, showing leaving from **Canada to Thailand** at least two times within six months, and a travel plan for the second entry can apply for a multiple entry
 - 4. A copy of recent bank statement (20,000 Baht per person or 40,000 Baht per family) (The name of the applicant must indicated clearly),
 In case of submitting family bank statement a proof of relationship.
 (i.e.birth certificate, marriage certificate) must be provided.
 - 5. Proof of accommodation in Thailand

For non-Canadian citizens

—a copy of the permanent resident card or a copy of valid Canadian Student/Work Visa (no Visitor Visa).

Validity of a visa: 90 days to enter the kingdom

Period of stay: Upon arrival, travelers with this type of visa will be permitted to stay in Thailand for a period of not exceeding 60 days.

Extension of stay:

Those who wish to extend their visa must file an application for permission at the Office of Immigration Bureau located on Government Center B, Chaengwattana Soi 7, Laksi, Bangkok 10210, Tel 0-2141-9889 (please visit http://www.immigration.go.th). The extension of stay as well as the change of certain type of visa is solely at the discretion of the Immigration officer.

Please note: Consular officers reserve the right to request additional documents as deemed necessary and also reserve the right to reject any application without having to provide reason.

Fee -\$65 for single entry or \$280 for multiple entry (60 days per entry). There will be **NO REFUND** if visa application is rejected or you apply for wrong type of visa.

To Remind: Your visa request may be denied when:

- (1) upload unprepared documents and photo;
- (2) information uploaded does not meet requirement; and
- (3) applying for wrong visa.
- You must complete the online application with your full name, as it appears on the passport. If completed incorrectly, you will have to re-apply for the new one and resubmit the payment. Please note that the form cannot be modified after the payment is made.

Step 2 – Submit Application

Upon completion of an online visa application from the applicant, the Royal Thai Consulate-General will review the application. If the application is approved, the visa will be issued electronically to the applicant's email provided in the application. Applicants no longer have to submit the original passport to the Consulate-General.
