Non-Immigrant O-A visa 1 year (Retirement)

Step 1 – Online e-Visa Application

The applicant who does not have a valid visa or re-entry permit must apply for a visa by: Complete the online e-Visa Application at https://thaievisa.go.th/ and upload the following documents in PDF format:

- 1. One passport-size photograph (2"x2" JPEG format) taken within 6 months. Photographs must have a light color background with a full- face view of the person without wearing a hat or dark glasses and covering up shoulders
- 2. A copy of Passport (must not expire within 18 months) (JPEG format)
- 3. A Medical Certificate issued from the country in which the application is submitted, showing no prohibitive diseases as indicated in the Ministerial Regulation No. 14 (B.E. 2535) (this certificate shall be valid for no more than 3 months). **This must be stamped by a medical doctor**
- 4. Proof of financial (letter from the bank) showing a deposit of the amount equal to no less than 800,000 Baht or an income certificate (original copy) indicating a monthly income of no less than 65,000 Baht.
- 5. A criminal record check indicating that the applicant has no criminal record in the country of his/her nationality or residence (this document must be valid for no more than 3 months and **must be notarized**)
- 6. Health insurance which covers the whole period of stay in Thailand (one year). Must purchase from Thai Company only. A list of Thai Insurance companies participating in the scheme can be found at https://longstay.tgia.org
- 6.1 For In-patient: health insurance policy must have coverage at least 400,000 Thai Baht per policy year.
- 6.2 For Out-patient: health insurance policy must have coverage at least 40,000 Thai Baht per policy year.
- 6.3 Letter from health insurance which covers COVID related medical treatment and coverage of no less than 100,000 USD, covering the whole intended period of stay. In case that the applicant intends to stay in the Kingdom for more than one year, the health insurance should cover at least the period of stay in Thailand.

For non-Canadian citizens

-a copy of the permanent resident card or a copy of valid Canadian Work/Study Visa/Permit

- For self-employed, business license or business registration indicating the applicant's name.

Fee - \$280 Cad. There will be **NO REFUND** if visa application is rejected or you apply for wrong type of visa.

To Remind: Your visa request may be denied when:

- (1) upload unprepared documents and photo;
- (2) information uploaded does not meet requirement; and
- (3) applying for wrong visa.
- You must complete the online application with your full name, as it appears on the passport. If completed incorrectly, you will have to re-apply for the new one and resubmit the payment. Please note that the form cannot be modified after the payment is made.

Step 2 – Submit Application

Upon completion of an online visa application from the applicant, the Royal Thai Consulate-General will review the application. If the application is approved, the visa will be issued electronically to the applicant's email provided in the application. Applicants no longer have to submit the original passport to the Consulate-General.
